

**Office of the State Selection Board,

The Tenth meeting of the State Selection Board, Department of Higher Education, Government of Odisha, Bhubaneswar, though scheduled to be held at 11.30am, on 11<sup>th</sup> August, was held at 3.30pm in the office Chamber of the Director, Higher Education, in the Heads of Department building. The meeting was started with a welcome address by the President SSB followed by a discussion on the proceedings of the last meeting, especially on the response of the government of Odisha in the Department of Higher Education were discussed and appreciated. The preparation relating to the initiation of the hoisting of the official web-site of the SSB was discussed and the trial launching by the NIC, India, Bhubaneswar was verified and the following resolutions are adopted;

1. That, the Secretary, SSB is requested to make necessary corrections in the developing web-site and finalise in consultation with the President and the Member of the SSB.
2. That, the Vice-President, SSB is requested to finalise the date and the venue for hoisting of the official web-site of SSB in consultation with the Honourable Minister, Higher Education and the Principal Secretary to Government, Department of Higher Education.
3. That, the dates of the proposed meeting of the Subject Committee is rescheduled to 25<sup>th</sup> & 26<sup>th</sup> August 2015, as the SSB could not get administrative approval from the government in the Department Higher Education to hold the meeting on 6<sup>th</sup> & 7<sup>th</sup> of August 2015. Secretary, SSB is requested to look in to the matter personally and pursue the matter at the government level.
4. That, the Secretary, SSB is authorized to invite or change any member of the Subject Committee as and when required for the smooth and timely completion of the task.
5. That, the Higher Education Department be requested to allow the Secretary, SSB to hire at least one vehicle for the official use at the earliest.
6. That, the Application fee for the reserved category and the onetime age relaxation for the in-service candidates be left to the government for final decision at their level.
7. That, the next meeting of the board is scheduled to be convened during the first week of September, 2015 or on any day in the month of September with a short notice, in case of any exigency.

The meeting ended with a vote of thanks proposed by the Secretary, SSB.
