NOTICE

It is for information of all concerned that the verification of documents/certificates of shortlisted candidates for the post of Post-Graduate Teachers (PGTs) as per Advertisement No. 01/2023 shall commence from 13th November, 2023. Detailed list of shortlisted candidates and schedule shall be notified on the official website of the State Selection Board: www.ssbodisha.ac.in shortly.

Candidates are advised to stay updated by frequently visiting the website and to have the following certificates/documents ready for the verification on the date to be notified.

- 1) Hard copy of online application.
- 2) Attestation form duly filled in (Form to be uploaded in the SSB website along with the verification schedule).
- 3) H.S.C. or equivalent certificate and mark sheet in support of date of birth and percentage of marks issued by the concerned Board / Council.
- 4) Higher Secondary (+2) and Graduation (+3) certificate and mark sheet in support of percentage of marks / division / class.
- 5) Master's Degree certificate and mark sheet issued by any recognized University/ Institution.
- 6) B Ed. certificate and mark sheet issued by any recognized University / Institution.
- 7) Two recent passport size photographs similar to the one uploaded in the online application form mentioning his / her name and Roll number of the candidate at the back.
- 8) Conduct Certificate issued by the College / University / Institution last attended.
- 9) Caste Certificate issued by appropriate authority within the last three years.
- 10) Required Odia pass certificate issued by the Principal / Headmaster of the School indicating that the candidate has passed Odia in M.E. Standard.

- 11) Discharge Certificate issued by the Commanding Officer of the Unit last served wherever applicable.
- 12) Disability Certificate (indicating percentage of disability) of Physically Disabled candidates issued by the concerned Medical Board, wherever applicable. The cases of PwD candidates shall be referred to Appellate Medical Boards constituted by SS & EPD Department vide Notification No.9789, Dt. 21.12.2021 for re-examination. Their names shall be recommended to the Government only after receipt of authentication report from the Appellate Medical Boards regarding their disability.
- 13) Identity Card of Sports Persons issued by the Director of Sports, Odisha, wherever applicable.
- 14) If a candidate claims to possess qualification, equivalent to the prescribed qualification, the rule / authority (with number and date) under which it is so treated, must be furnished.
- 15) The qualification claimed by the candidate must have been attained by the last date of submission of on-line application form i.e. 25.07.2023.
